

Governing Board Address Topics Related to Equity and Inclusivity

At its regularly scheduled meetings on June 23, 2021, and July 14, 2021, the 4CD Governing Board discussed two agenda items representing 4CD's continued commitment to promote an atmosphere of respect for all students and employees:

- Resolution 22A : Recognizing June 2021 as Pride Month, with the intention to proudly fly the Pride Flag at its colleges and the District Office.
- Juneteenth: Applauding President Biden and the U.S. Congress' collective decision to commemorate Juneteenth as a national holiday and announcing the decision to make Juneteenth an official 4CD holiday through the shared decision-making and bargaining agreements.

These ongoing discussions should remind the 4CD community that the road to social, racial and economic justice is long and intensive. However, the 4CD Governing Board, leadership and greater community are committed to ensuring the equal treatment of all people including immigrants, people of color, practitioners of faith, individuals with disabilities, LGBTQIA+ individuals, and members of other protected groups.

Guided Pathways Make Progress

Members of the Board received an informative update from leadership across Contra Costa College (CCC), Diablo Valley College (DVC), Los Medanos College (LMC) and the District Office (DST) on 4CD's Guided Pathways progress at the regular July 14, 2021, meeting.

Presented by **Mark Akiyama** (DVC), **Emma Blackthorne** (DST), **Evan Decker** (CCC), **Natalie Hannum** (LMC), **Sally Montemayor – Lenz** (LMC), **Tanisha Maxwell** (LMC), **Mojdeh Mehdizadeh** (DST) and **Kimberly Rogers** (CCC), the update highlighted progress on 4CD Strategic Direction 1: Improve Student Learning and Completion across District Colleges with a focus on three specific objectives:

1. Aligning 4CD student completion goals with those identified in the CCCCO's Vision for Success;
2. Supporting college implementation of the state's Guided Pathways framework; and
3. Convening venues that bring together faculty, staff, and administrators across 4CD to share effective practices and reflect on progress toward successful targets.

During the presentation, college leaders shared various strategies being applied at their campuses in an effort to implement Guided Pathways and develop a framework to help students get, stay and work through pathways to reach their educational goals.

4CD Sees Increase in CCAP Agreements

The Education Services department was proud to present and receive approval for 27 College and Career Access Pathways Partnership Agreements (CCAP) at the regular Governing Board Meeting held June 23, 2021. One of the agreements included a new contract with Martinez Unified School District, a celebrated collaboration that unfolded remotely during the pandemic.

CCAP agreements create opportunities for public high school students to dual-enroll in college courses that generally satisfy high school graduation requirements. Under this unique type of agreement, college courses are made exclusively available to high school students, allowing colleges to provide focused resources to high school students at a given school. Though there are a few courses held on college campuses, these courses typically take place on-site at participating high schools, eliminating transportation challenges as a potential barrier to post-secondary education.

For Associate Vice Chancellor, Education Services **Kelly Schelin**, CCAP agreements produce a multitude of benefits, both for individual students as well as the larger community. “Rather than relying on a student’s initiative, social capital, or ability to navigate the enrollment process on their own, CCAP agreements enable colleges and high schools to collaborate and streamline the process for students, thereby increasing access for those students who might not otherwise have been able to access a given course,” shared Schelin. “CCAP agreements increase access to college courses for high school students by embedding the college course within the student’s high school day.”

Dual enrollment programs are essential in fostering a college-going culture among Contra Costa County high school students, an important goal supported districtwide. Research has shown that students who complete college credit while enrolled in high school are more likely to earn high school diplomas, to enroll in community colleges and four-year colleges, to attend post-secondary education on a full-time basis, and to complete degrees in those institutions than students without these experiences. The positive impact of dual enrollment is not only seen in degree outcomes, but also in cost savings. Students earning early college credit accelerates time spent completing a college degree or certificate and decreases future tuition costs for dual-enrolled high school students who have their enrollment fees waived.
