4CD Student Government Leaders Visit Washington D.C.

DVC managers **Todd Farr** and **Ada Ocampo**, along with a DVC delegation of 10 Associated Students of Diablo Valley College (ASDVC) students, and Student Trustee Surpreet Kaur, participated in the National Student Advocacy Conference held in Washington, D.C. The team conducted legislative visits with congressional offices, toured the U.S. Capitol, National Museum of African American History and Culture, Kennedy Center, and Smithsonian Museum of Natural History. ASDVC student leaders advocated for the DACA/DREAM Act, Pell Grant expansion, and support for HR 2861, America's College Promise Grant Act.

The composition of DVC students that attended this conference represented gender balance, first generation, first year students, international students, and transfer students from historically marginalized groups.

This is the first time in many years that 4CD has had student representation from all 3 colleges, with Los Medanos College Associated Students President Jeffrey Bui and five student representatives from CCCAS attending the National Student Advocacy Conference.

DVC's Arthur King Selected as 4CD Classified Employee of the Year

Arthur King, classified professional at Diablo Valley College, has been selected by the Classified Senate and approved by the Governing Board as the 4CD Classified Professional of the Year. He will now be considered for the statewide California Community Colleges Classified Professional of the Year awards. The purpose of this statewide award is to recognize outstanding classified professionals throughout the community college system.

Having over 25 years of experience in this role, he has expanded his duties to include organizing Art Department fundraisers, hosting high school student outreach events, and college transfer presentations. His commitment as Gallery Coordinator is tremendous. He organizes at least five annual exhibitions including the Annual Student Art Exhibit wherein each DVC Art student can showcase their work. Arthur schedules, coordinates, and installs

every exhibition at the DVC Gallery and manages the permanent DVC Art Collection.

Arthur is motivated by a desire to contribute to a more equitable and excellent college. His general motto is, "If it helps students, then I'll do it." Arthur always gladly makes himself available to any student or instructor who approaches him. His presence is a huge reason the DVC Art Department is a welcoming community.

Statewide award winners are selected by representatives of the Community Colleges' Board of Governors, Chancellor's Office, and the Foundation for California Community Colleges. Recipients will be announced and honored at the May meeting of the Board of Governors. The nominees are evaluated on their commitment to the Vision for Success and equitable student outcomes; professional ethics and standards; serving the institution's diverse student population through participation in professional and/or community activities; and serving as a leader beyond their location institution. A \$750.00 cash award and plaque will be awarded to six statewide recipients.

4CD Implements AB 367

• O n October 8th, 2021, Governor Gavin Newsom signed AB 367, which required the CSU system and each community college district in the state to provide free menstrual products in at least one "designated and accessible central location" on campus by the 2022-23 academic year.

While 4CD is in full compliance with the law, each college added more locations where free menstrual products are available. At Contra Costa College, there are currently 10 dispenser locations with plans of adding 10 more. At Diablo Valley College there are 9 locations across the Pleasant Hill Campus, and one at the San Ramon Campus. Dispensers are in each building across Los Medanos College at both the Pittsburg campus and Brentwood Center, as well as in the student marketplace.

Maintenance & Operations teams installed the dispensers, while the custodial staff restocks them. There is also a number on the dispensers that students can text if the supply is empty.
